

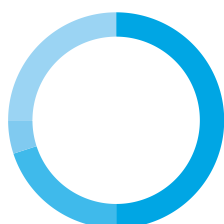
# Bonds strategy (100% bonds)

## Investment goal

The bonds strategy is appropriate for investors with an investment horizon of at least 3 years who only want to take on slight price risks. This strategy comprises over 2200 bonds with different terms ranging from one year to several years. The creditworthiness of the bond portfolios is high.

- Corporate bonds hgd 25%

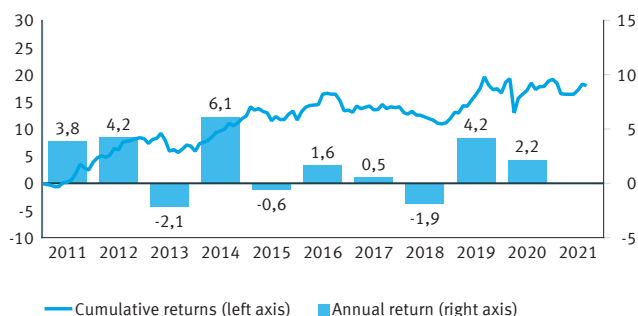
